#### Item 5.07. Submission of Matters to a Vote of Security Holders.

On June 6, 2023, Hostess Brands, Inc. (the "Company") held its 2023 Annual Meeting of Stockholders (the "Annual Meeting"). At the Annual Meeting, the Company's stockholders voted on three proposals and cast their votes as set forth below.
